For safety reasons, we require that all volunteers wear closed-toe shoes when they come to volunteer. Cell phones cannot be used inside the distribution center at any time. Any personal calls can be taken inside the break room or outside of the distribution center. Food and other products at Love N Cherish Family Center, Inc. Food Pantry are strictly for distribution to clients meeting eligibility criteria. Volunteers are not allowed to take any food product from Love N Cherish Family Center, Inc. Food Pantry. Love N Cherish Family Center, Inc. Food Pantry is a drug, smoke, and alcohol-free workplace. Any volunteer who takes food or distributes, possesses, or arrives under the influence of any drug or alcohol will be asked to leave.

Youth Policy: Volunteers ages 15 and under cannot volunteer inside the distribution center at Love N Cherish Family Center, Inc. Food Pantry, as per OSHA guidelines. However, accommodations can be made with the Volunteer Coordinator for the participation of volunteers age 15 and under. Volunteers ages 16 and 17 who will volunteer in our distribution center must be accompanied by an adult 18 years or older in a 1:5 ratio of adult to youth. Volunteers ages 16 and 17 who will volunteer in our office can volunteer without an adult.
