



# EDUCATOR POLICY

School Year: 2018-2019

**Position Statement:** Love N Cherish Academy is a family-centered educational environment that understands the importance of education and the impact of family involvement and support in the education process at an early age.

**Policy:** Love N Cherish Academy offers a professional courtesy to our educators in our local school systems (Rock Hill School District, York School District, Charlotte Mecklenburg School District, Lancaster Country School District, and Chester School District) during extended school district breaks. Parent/guardian must present written documentation of employment as an educator to participate in this program.

Our local teachers can dis-enroll their child/children during Spring Break, Winter break, and Summer Break. Tuition for those weeks will be waived, however to hold your child's space for the fall (August), teachers must pay the yearly \$150.00 Activity Fee (\$135.00 for each additional child) NO LATER THAN MAY 31 each year.

Teachers may begin paying on these fees each January; however, balance must be paid in full no later than the first Wednesday in June. Fees can be spread over a period (not to exceed 4 weeks).

Teachers must notify Love N Cherish Academy of the dates of their districts breaks for the upcoming year on the first day in attendance at Love N Cherish Academy in the fall.
